Definitions:

Personal data: "Personal data" means data submitted, stored, sent or received to or via the WonderWorld Site or applications by a user such as your name, address, phone number, and email address or financial data such as your credit card number, expiration date, and verification code or bank account information, IP address or other "legal data" such as your social security number or other information relating to you as an identified or identifiable person.

GDPR: General Data Protection Regulation is the EU regulation on data protection and privacy for all individuals within the European Union. It also addresses the export of personal data outside the EU. The GDPR aims primarily to give control back to citizens and residents over their personal data and to simplify the regulatory environment for international business by unifying the regulation within the EU.

1. What information do we collect from users

1.1 Personal Data we require from you

In order to open an account, you will be asked to provide us with your full legal name, national identification document such as passport and or driving licence and email address in compliance with Know Your Customer (KYC) and Anti-Money Laundering (AML) policies.

To complete your personal profile, you will have to upload a personal picture, video or animation which we can confirm identifies you as a person according to your identification document.

If you fail to provide this data when requested, we may not be able to perform the contract we have or are trying to enter into with you. In this case, we may have to cancel the product or service.

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

Where we need to perform the contract, we are about to enter into or have entered into with you; Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests;

Where we need to comply with a legal or regulatory obligation.

Please refer to the details outlined in this Privacy Policy accordingly.

1.2 Traffic/visitor Data. WonderWorld may collect a variety of visitor data such as IP addresses, browser settings, internet service provider (ISP) information, referring/exit pages, operating systems, date/time stamps, and clickstream data. The WonderWorld internal servers and software may automatically recognize such visitor data. The Site may use visitor data to compile data about the types of visitors who use the Site at specific intervals (collectively "Traffic Data").

We may use Traffic Data to analyse Site traffic, but this information is not examined for Personal data. We may also use Traffic Data to diagnose problems with our server, administer our Site, or display content according to your preferences. Traffic Data may be shared with business partners, affiliates, or advertisers on an aggregated and anonymous basis[NL12].

- **1.3 Web Beacons.** We may employ a software technology called clear gifs (a.k.a. web beacons), that help us track referrals from our partners and affiliates and better manage content on our Site. Clear gifs are tiny graphics with a unique identifier, similar in function to cookies, and are used to track the online movements of web users. In contrast to cookies, which are stored on a user's computer hard drive, clear gifs are embedded invisibly on web pages and are about the size of the period at the end of this sentence. We do not tie the information gathered by clear gifs to our customers' Personal data.
- **1.4 Third Party Tracking.** The use of tracking technologies by our service providers, technology partners or other third parties (such as social media links) on the Site is not covered by our Privacy Policy. These third parties may use cookies, clear gifs, images, and scripts to help them better manage their content on our Site. We do not have access or control over these technologies.
